SECTION B: CONSIGNED AGREEMENT TERMS

This Agreement is made by and between greekcity.com and or Greek City Music Ltd., herein referred to as the 'SELLER' and _____ herein referred to as the CONSIGNEE. WHEREAS the Seller provides the items, those indicated in Section A. hereto (the 'Goods') **by consigning** said Goods to Consignee/Company/Organization for sale for the given consigned period indicated below.

CONSIGNEE'S OBLIGATIONS:

- (a) **CONSIGNEE.** The Consignee accepting all the provisions of this contract and/or full responsibility for the consigned merchandise must be the Chairman/Head of the Organization.
- (b) **SIGNED LETTER.** The Consignee must send a signed letter to the Seller/Supplier, on their Company letterhead, naming the individual (ie the Chairman of Org.) who will take full responsibility of the consigned merchandise while in their possession and will pay for any damaged, lost, or stolen merchandise while in their possession during the consigned period.
- (c) **RECEIPT OF CHEQUE.** The Consignee must ensure that a company cheque is received by the Seller, within **seven (7)** business days from the termination of the Event/Festival. The monetary value of the cheque must be equal to that of the consigned merchandise sold as stipulated in the attached Packing Slip form included with the consigned merchandise shipped to the Consignee. The Consignee agrees to pay for the shipping cost of the consigned merchandise, of which was pre-paid by the Seller.
- (d) **UNSOLD/RETURNED MERCHANDISE:** The Consignee agrees to return **all unsold consigned** merchandise to the Seller in the **exact condition** in which it was received by the Consignee within one week (1) of the termination of the Event/Festival. **If any of the merchandise is damaged or dirty it will be considered as SOLD PRODUCT.**
- (e) **RETURN OF GOODS.** The Consignee agrees to return all unsold consigned merchandise to the Seller at the Consignee's expense, and agrees to apply and pay for transit insurance in the event that the merchandise is lost, stolen or damaged during transportation back to the SELLER.
- (f) **SHIPPING CHARGES TO AND FROM FESTIVAL:** The Consignee must **LEAVE ON-ACCOUNT** the amount of \$500 for shipping charges. Once the consignment product has been returned to Seller/Supplier and the Shipping costs to and from the festival have been documented then either a credit will be applied to the Consignee or a Balance Owing will be applied to the final invoice.
- (g) **RE-STOCKING CHARGES:** If the Consignee **DOES NOT SELL** a minimum of \$1,000.00 – there will be a 10% re-stocking fee applied to the total amount **of UNSOLD Returned Items**. The 10% Amount will be added to the final invoice owed.
